Terms and Conditions

## Sands Holiday House

**Availability** – The booking is made on the understanding that we will make the accommodation available to you on the dates stated. Should this not be possible due to events beyond our reasonable control, we will endeavour to provide you with alternative accommodation. Should no other accommodation be available at the time we will offer you alternative dates or refund your accommodation rental, but you will have no other claim or remedy against us.

**Responsibility** – The signatory to the booking form accepts full liability for the behaviour of all party members and for ensuring all conditions are adhered to, for loss or damage to the accommodation and the contents.

**Personal Effects** – We will not be held responsible for the loss or damage to personal property of guests. Postage and packaging will be charged for return of belongings left behind. Any lost property not claimed for within one month will be disposed of.

**Payment** – To make a reservation a £100 deposit is required, payable by card or cheque to J & M Cameron. Balance is due two weeks before holiday commencement.

**Arrivals and Departures** – The house will be available to guests from 4pm, on arrival keys will be picked up from reception at the Sands Caravan and Camping Reception. The house must be vacated by 10am on the day of departure unless otherwise arranged through management.

**Good Housekeeping** – On arrival a good house keeping deposit of £200 will be required before keys are provided. This can be paid in cash, cheque or credit card details. All monies will be returned in full provided the accommodation is left as found. Any damage to accommodation and equipment or environment will be charged against the total retainer.

**Cleaning** – The house should be left clean and tidy on departure, cleaning equipment is provided. Any damages must be reported and paid for at reception.

**Dogs** – Dogs are allowed in the house at owner's discretion – please ask before you bring your pet. Dogs are not allowed on beds or furniture.

**Smoking** – No smoking is allowed in the house.

**Occupancy** – Only those persons listed on the booking form may occupy the accommodation. If this condition is breached we have the right to terminate the contract immediately, without refund. Any unauthorized extension of stay will be charged at full daily rate.

**Linen** – Duvet covers, pillowcases and fitted sheets are supplied, as are towels – all free of charge.

**Cancellation** – If you require cancelling a reservation for any reason we must be notified by telephone immediately. In the event of cancellation every effort to re-let the house will be taken and you will be reimbursed in full (minus £30 administration fee). If we are unable to re-let cancellation costs are as follows:

- Over 4 weeks, your deposit will be forfeited
- Less than 4 weeks you will be liable to pay the full cost of rental
